## COUNTERING HUMAN TRAFFICKING IN THE PERUVIAN AMAZON (PHASE TWO)

Peru is a source, transit, and destination country for victims of sex trafficking and forced labor. USAID provides technical assistance to the Peruvian government in implementing the new C-TIP National Policy approved in July 2021.

### HOW DOES THE ACTIVITY WORK?

The activity strengthens the Government of Peru's ability to combat human trafficking. USAID provides technical assistance to the interagency commission that coordinates Peru's anti-trafficking efforts to prevent, prosecute and sanction human trafficking. USAID also supports legal and psychological assistance to trafficking survivors and their families through its implementing partner Capital Humano y Social Alternativo's (CHS) Center for Legal and Psychological Assistance.

During Phase One, CHS conducted relevant research to produce evidence about human trafficking to strengthen the national action plans against trafficking in persons; supported the establishment of a national network of justice system actors (prosecutors and judges) to strengthen their capacities to investigate, prosecute, and sanction human trafficking; technical assistance was provided to regional governments to develop their Regional Action Plans Against Human Trafficking; produced and disseminated five reports analyzing the implementation of action plans (national and regional) against human trafficking; and supported 385 victims received specialized legal and psychosocial assistance.

## RESULTS ACHIEVED

- The CHS Center for Legal and Psychosocial Attention has provided services for 149 trafficking in persons (TIP) victims during the first 18 months of program implementation.
- CHS has promoted alliances among civil society oversight committees and elected officials to advocate for countering TIP efforts. Agreements have been reached with four members of Congress representing Cusco (2), Lima (1), and Madre de Dios (1) regions.
- Technical meetings, virtual and in person training on Victims-Centered Approach, Trauma-Based Approach and gender stereotypes were delivered to more than 250 justice and care service operators, among public defenders, prosecutors, and judges.
- Specialized technical assistance to Regional Governments to include C-TIP activities and indicators to monitor progress against human trafficking on their Regional Operational Plans based on the new C-TIP Peruvian National Policy approved in July 2021.
- Informational and awareness campaigns in the prioritized regions to prevent and identify TIP victims and denounce cases before the authorities.
